VST - Lane Community College from the Holiday Inn Express Hotel & Suites, Springfield.

Go right on Hutton and take the first left on Beltline. Merge onto Interstate 5 (I-5) south towards Roseburg. Take Exit 189 towards 30 th Avenue. Turn right onto OR 225/ McVay Highway. Turn right on East 30<sup>th</sup> Avenue. Go 0.6 miles past Eldon Shafer DR to LCC. The staging area is in parking lot K.
