Test limitations

These events are being scheduled as part of the Otterhound Club of America combined tracking test in accordance with the AKC combined test policy addressed in Sections 13a and 15 of the American Kennel Club Tracking Regulations.

The Test will be limited to 4 TDs, 2TDXs and 2 VSTs (Otterhounds only)

If the entry limit is not reached in one test and the entry limit is exceeded in another test, the Test Secretary may exchange the number of tracks through plotting day. The following substitution rule will be used: 2 TDs = 1TDX = 1 VST.

In the event of extreme weather conditions, OHCA reserves the right to cancel these events in accordance with AKC regulations.

Unentered dogs are not allowed on the tracking grounds.

Closing date: Wednesday, August 24, 2011, 5:00 p.m. after which time entries cannot be accepted. All entries will be accepted until the official closing date & time, even if the advertised limit has been reached.

Entry Fee: TD - \$65.00; TDX - \$95.00; VST-\$95.00. Fee includes AKC recording and event fees. Make checks payable in US funds to OHCA and submit with entry.

Certification: Each TD entry must be accompanied by an original certification issued by an AKC approved tracking judge. Dogs that possess a title of TD are exempt from this requirement.

Acknowledgement will be mailed by the Test Secretary after entry receipt. If an acknowledgement is not received within a reasonable time, please notify the Test Secretary at (509) 773-1967 or ohca@klickitat.org. Applicants who provide an e-mail address will be notified by e-mail.

Entry Drawing: A drawing to select entrants and alternates will be held on Wednesday, August 24, 2011, at 6 PM at Ayutla's Restaurant, 630 East Simcoe Drive, Goldendale, WA, 98620. Entrants are invited to attend. The drawing will be random except that preference will be given as follows:

- 1. Otterhounds without a TD, TDX or VST title;
- 2. Otterhounds with a TD, TDX or VST title.

After 4 TDs, 2 TDXs and 2 VSTs have been drawn, all remaining entries will be assigned a numerical ranking on an alternate list corresponding to the order in which they were drawn.

Alternates: Alternates will be asked if they wish to stay on the list in the event of a withdrawal. Those who do are requested to attend the track draw on September 8. Alternates not used will receive full refund of entry fees. OHCA will also refund fees to any confirmed entrant who withdraws from the test, by written or email notification to the Test Secretary by September 7, 2011, at 11 AM provided that an alternate entry participates in the test as a result of the withdrawal.

Track Draw:

All VST entrants must be at Parking Lot K, Lane Community College, by 6 AM September 8, 2011. All TD and TDX entrants must be present at the Bear Creek Pheasant Farm meeting room by 9 AM, September 8, 2011.

A track draw is held for each dog entered. The first track for each test will be run after the track aging requirement has been met. In the event of any absentees among confirmed entries, the next alternate in catalog order who is present, will be allowed to fill the vacancy.

Bitches in Season:

AKC's Tracking Rules and Regulations, Chapter 2, Section 8, allow a bitch in season to participate only at the test-giving club's option. Bitches in season will not be allowed to participate for this Otterhound tracking test.

Tracking Site Details:

Parking: Sufficient parking is available at both the Bear Creek Pheasant Farm and in Parking Lot K at Lane Community College. Please do not block roadways or exit aisles with your car or setup.

Overnight camping is not available at either site, but the host hotel, the Holiday Inn Express and Suites, Springfield, is less than a half hour drive from the Pheasant Farm and 10 minutes from Lane Community College.

Refreshments and Lunch: Refreshments will be provided for exhibitors and spectators on the morning of the test. Lunch will be available onsite at the Pheasant Farm.

Awards: A custom embroidered tracking-themed tote and a framed, enhanced track map will be provided to each successful tracking team.
